

GENERAL SWEEPSTAKES RULES FOR RED ROCKS AMPHITHEATRE ANNUAL POSTER CONTEST

These are the general rules covering the *Red Rocks Amphitheatre Annual Poster Contest* (“Sweepstakes”). If you have a question, please contact Amy Lindsey at 720-373-5419 or amy.lindsey@denvergov.org.

1. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

2. How to play: entrants shall submit their artistic interpretation of Red Rocks Park & Amphitheatre via www.redrocksonline.com between August 28, 2017 and October 9, 2017.

Submissions will be accepted in electronic format and must include the following:

- Text – Artwork must include “Red Rocks Amphitheatre, 2017 Morrison, Colorado” and Artist Name;
- Size - The final printed poster will be 24” wide x 36” high and artwork should be sized accordingly (with or without a border)
- Resolution / File Format - Artwork should be a minimum of 300DPI and in .JPG, .TIFF or .PDF format.
- Original artwork (e.g. paintings, sketches) should be scanned and submitted electronically

3. Eligibility: To enter the Sweepstakes you must be a legal U.S. resident. Entrants under 18 must have a parent or guardian sign for them if they receive a Prize. Sweepstakes is void where prohibited by law. Employees or anyone otherwise affiliated through any type of employment arrangement with the Sweepstakes sponsor, City and County of Denver (“Sponsor”), and their immediate families and members of their households, are all ineligible to participate in Sweepstakes.

4. Transfer: No transfer, substitution or cash equivalent shall be substituted for the *Chipotle Yoga on the Rocks Instagram Contest* Sweepstakes. All federal, state, or other tax liabilities (including income taxes), and any other subsequent expenses are the sole responsibility of each winner. The estimated retail value of each Prize is \$_____.

5. Consumer Disclosure:

For the *Red Rocks Amphitheater Annual Poster Contest on August 28, 2017* (the “Prize”).

6. Prize Drawings: One winner will be selected from entries received via online by successfully responding to the *Red Rocks Amphitheatre Annual Poster Contest* between

August 28, 2017 and October 9, 2017. Prize must be claimed by 12 p.m. on October 29, 2017. Winner will receive one pair of tickets to a 2018 Red Rocks concert of choice and will be based on availability.

7. Odds of Winning: Odds of winning are dependent on the number of responses to the *Red Rocks Amphitheatre Annual Poster Contest*.

8. Prize Conditions: Potential winner(s) will be required to execute an Affidavit of Eligibility, a Liability Release and a Publicity Release ("Affidavit/Release"). If the potential winner fails to complete the document at the time he/she picks up the Prize, is found to be ineligible, or does not comply with the Official Rules, then the potential winner will be disqualified. Prizes are nontransferable. All federal, state, or other tax liabilities (including income taxes) arising from this Sweepstakes will be the sole responsibility of each winner. Except where prohibited by law, the winner's entry and acceptance of the Prize constitutes permission for the Sponsor to use said winner's name, initials, photograph, likeness, statements, biographical information, voice, and city and state address on a worldwide basis, and in all forms of media, in perpetuity, without further compensation. Sponsor will receive unlimited rights to winning artwork for use in future promotional material (e.g. website, advertisements, social media.) Artist will not receive a percentage of sales on future products incorporating artwork should the Sponsor decide to reproduce. Winner will be required to sign a release of creative content release form.

9. Sweepstakes Conditions: This Sweepstakes is subject to all federal, state and local laws. By participating, entrants agree to be bound by these Official Rules and the decisions of the Sponsor and waive any right to claim ambiguity in the Sweepstakes or these Official Rules. Once Notification of winning has been sent, the Sweepstakes winner will have 3 business days in order to claim it, and Sweepstakes winner will be ineligible to win another Prize through the Sponsor for thirty (30) days.

10. Indemnification: Winners and entrants agree to release, discharge, indemnify, defend and hold harmless the City of Denver, its officials, employees and contractors from and against any claims, suits, actions, damages or liability of any kind or nature due to any injuries, damages, or losses to any person, including death, or property of any kind resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of any Prize or participation in this Sweepstakes.

11. Limitations of Liability: The Sponsor is not responsible for lost, late, misdirected, undeliverable, or incomplete entries. The Sponsor may prohibit an entrant from participating in the Sweepstakes or winning a Prize if, in its sole discretion, it determines that said entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, deception, or other unfair playing practices or intending to annoy, abuse, threaten, or harass any other entrants or Sponsor representatives. The Sponsor is not responsible for lost entries due to electronic malfunctions. If for any reason this Sweepstakes is not capable of running as planned as a result of any causes beyond the reasonable control of Sponsor including but not limited to tampering, unauthorized

intervention or fraud which corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Sweepstakes, then, the Sponsor reserves the right at its sole discretion to cancel, terminate, modify, or suspend the Sweepstakes.

12. Notification:

- a. Notification shall be sent to winner via email provided on www.redrocksonline.com during contest entry. The Sponsor is not liable for any electronic malfunctions.
- b. The Sponsor will not remind winners of the deadline for claiming their Prize. It is the responsibility of the winner to claim the Prize within the specified timeframe of five days from notification. If the Prize is not claimed by 12 p.m. October 29, 2017, the Prize will automatically be forfeited and may be awarded to another contestant. The Sponsor is at liberty to give away any unclaimed Prize.
- c. The winner shall personally accept the Prize, at the Denver Arts & Venues Office at 1345 Champa Street, Denver, CO 80204. Should electronic tickets be available, tickets will be sent to winner via email at the email address provided by the winner after verification of identity.
- d. Under "unique circumstances," a representative designated by the winner may be allowed to accept the Prize. Written authorization from the winner including representative's name, ID, and a photocopy of the winner's valid driver's license and a power of attorney authorizing the representative to accept the Prize on behalf of the winner is required. A "unique circumstance" shall be an unparalleled and incomparable event that is in no way attributable to the carelessness, oversight or negligence of the Prize winner.

13. The Prize will be awarded on an available basis.

14. The Sponsor may substitute another Prize of equal value, in the event of non-availability of a Prize.

15. The Sponsor is not responsible for any complications with the Prize. The Sponsor is not required to compensate the winner for any cancelled performances for any reason.

16. The Sponsor is not responsible for any computer, browser, server, or other equipment malfunction that may or may not interfere with Sweepstakes entries or notifications. Winners will be selected only from entries received by the deadline.

17. Employees or anyone else affiliated with the Sponsor and their families or households are ineligible to enter/win any Sweepstakes staged on the Sponsor owned and operated web sites.

18. Additions or deletions to these rules may be made at the discretion of the Sponsor and may be enacted at any time.
